You may setup the day off, however, **ALL VENDORS must be prepared and ready to go by 8:45am.** We will be using the gym and hallways for setup. Vendors are required to clean-up their area before leaving at end of day.

**Raffle Items:** Each vendor is required to donate an item to the holiday raffle. **20% of Raffle sales proceeds is a donation to the BES School for kids programs.** Each item will be displayed and folks will purchase raffle tickets to be entered in the item of their choice. Raffle Tickets are: 1 for \$2, 10 for \$5. **THOSE ITEMS ARE DUE THE NIGHT BEFORE EVENT PREFEREABLY.**
